THE 2020 "ACES OF FINANCE" COMPETITION IS OPEN

MONTREAL, September 12, 2019 — The <u>Quebec Chapter of FEI Canada</u> is proud to present the 10th edition of its prestigious competition, the **Aces of Finance**. All financial executives working in Quebec, whether members or non-members, are invited to submit their nominations for this year's awards. Created in 2011, the **Aces of Finance** competition aims to recognize the professional achievements and community involvement of outstanding Quebec financial executives.

Nominations will be accepted until **February 17**, **2020**. The names of the winners will be revealed at the 10th anniversary gala on **May 6**, **2020**. The competition rules and nomination form are available on the FEI Canada/Quebec Chapter website. The association reminds everyone that the Quebec Chapter of FEI Canada is the all-industry professional membership association for senior financial executives in Quebec.

Categories

The Aces of Finance competition comprises three categories:

- **Financial executive of a large corporation** Revenues of more than \$500M and/or over 1,000 employees. The candidate must have occupied this position for at least two (2) years.
- Financial executive of a small or medium-sized enterprise The candidate must have occupied this position for at least two (2) years.
- Emerging financial executive The candidate must be 40 years old or younger at the deadline for submitting nomination forms and must not be the principal financial officer of his/her company. The candidate may report to the CFO and be in the role of a Vice-President/ Finance, Treasurer, Controller, etc.

Why participate?

Because the career of a corporate finance executive involves working in an ever-changing and demanding economic environment, and being nominated in the **Aces of Finance** competition is an indelible way to honour one's accomplishments.

Macky Tall, Honorary Chairperson

For the competition's 10th anniversary, **Macky Tall**, Head of Liquid Markets at Caisse de dépôt et placement du Québec and President and Chief Executive Officer of CDPQ Infra, has graciously agreed to be this year's honorary chairperson. Mr. Tall has had an exceptional career path. He is currently leading the largest public transit project in Quebec of the last 50 years – the Réseau express métropolitain (REM). Since joining the Caisse in 2004, Mr. Tall has actively contributed to the implementation of a business model focused on strategic partnerships with the largest infrastructure operators in the world, in many key sectors such as renewable energy, transportation, energy distribution, airports and ports. This approach enabled the Caisse to build a portfolio valued at over CAD\$20 billion. Mr. Tall previously held several senior management positions at Hydro-Québec, MEG International, Novergaz and Probyn & Company. He is a member of the infrastructure advisory board of the Department of Foreign Affairs, Trade and Development Canada (DFATD). He has also been co-chair of the Advisory Committee of the Global Infrastructure Facility of the World Bank.

2020 Homage Award

At the gala on May 6, 2020, the Quebec Chapter of FEI Canada will also be awarding its **Aces of Finance Homage Award** to a financial executive who has had a distinguished career. The 2020 recipient of this prestigious award is **Louis-Philippe Carrière**, FCPA, FCA, who worked at Saputo Inc. for over 30 years before retiring in 2017. Since then, he has been serving on the Saputo Board of Directors and as Senior Advisor to the company. Having joined the group in 1986, Mr. Carrière's journey at Saputo has been a long one. During his career, he held various management positions in finance and administration. As Chief Financial Officer, from 1996 to 2017, he helped formulate growth strategies and developed the company's financial strategy. Mr. Carrière holds a bachelor's degree in management from the École des Hautes Études Commerciales de Montréal and has been a member of the Ordre des comptables professionnels agréés du Québec (Québec CPA Order) since 1985. He was appointed Fellow of the Ordre des comptables professionnels agréés du Québec in 2007. He also sits on the Board of WSP Inc. and chairs their audit committee.
