## Call for Candidates

The **QUÉBEC CHAPTER** of Financial Executives International Canada is proud to present the eleventh edition of The Aces of Finance competition, which will be **presented under the honorary presidency of Mr. Guy LeBlanc, President and Chief Executive Officer of Investissement Québec**. The purpose of this contest is to recognize the performance of three outstanding financial executives in Québec. **THE ACES OF FINANCE** awards represent a golden opportunity to acknowledge and reward the stellar careers of three financial executives. The goal is to spotlight outstanding professional achievements and contributions within the community of talented Vice-Presidents of Finance and Chief Financial Officers. The financial executives who receive this honour will also serve as inspirational models for future generations.

**Candidates are invited to submit for one (and only one) of the following three categories:**

- Financial Executive of a **large corporation** (>\$500M revenues or 1,000 employees)
- Financial Executive of a **small or medium-sized enterprise**
- **Emerging** Financial Executive\*

*\*The candidate must be 40 years old or younger as of the application deadline. The candidate may not be the primary finance person of their company. The candidate may report to the CFO and be in the role of a Vice-President of Finance, Treasurer, Comptroller, etc.*

**Eligibility criteria are as follows:**

1. The candidate must have occupied this position within the company for at least two years as of the application deadline. *(Does not apply to the Emerging Financial Executive category)*
2. The candidate must be a Canadian citizen or landed immigrant and a resident of Québec.
3. Finalists must be available to meet with the jury on March 24 and 26, 2021 and attend the unveiling event that will be held in honour of the award winners on May 5, 2021 in Montréal at 5:30 p.m.

<b>February 26, 2021</b>	Pre-selection of finalists
<b>March 24 and 26, 2021</b>	<b>Meetings between finalists and the jury</b> Finalists will be invited to meet the members of the jury on March 24 and 26, 2021. According to the sanitary measures in effect at the time, this meeting, which lasts about an hour and a half, will take place between 8:00 a.m. and 5:00 p.m. in downtown Montreal or virtually. Kindly keep this date open in your agenda. The exact time will be confirmed on March 1st, 2021 at the latest.
