## CFERF Privacy Policy

### Privacy Policy

Financial Executives International (FEI) Canada and the Canadian Financial Executives Research Foundation (CFERF) are committed to respecting and protecting your personal privacy. As [www.feicanada.org](http://www.feicanada.org) functions primarily for members, our website is divided into two major sections: that portion that is available to all visitors, and that portion that is designed for members only. CFERF currently shares the same website. All CFERF information is available to all visitors. CFERF does not have members.

There are a few instances where we do collect personally identifiable information. For instance, members are asked to provide their member number/ID in order to access "Members Only" portions of the site. Or, when registering for a conference or e-newsletter subscription, for example, a user (member or non-member) is asked to provide his or her name, e-mail, company name and some limited demographics of his/her industry. This information is submitted voluntarily.

Similar information may be submitted to FEI Canada and CFERF through membership applications, conference or teleconference registration, and magazine or e-newsletter subscriptions. Likewise, FEI Canada and CFERF does not disclose credit card account information provided by its members and customers, sponsors or donors. When members and customers, sponsors or donors choose to pay using their credit cards, FEI Canada and CFERF submits the information needed to obtain payment to the appropriate clearinghouse. We do not provide or sell credit card or other personally identifiable information to third parties. For the purposes of this privacy policy CFERF is not considered a third party.

FEI Canada and CFERF do not share the contact information of members and customers, sponsors or donors with any third party. FEI Canada and CFERF does on occasion employ the services of a mailing house under confidential contract to package and send mail by Canada Post to our members and other customers, sponsors and donors.
