The final membership results are in for the year. FEI has 2127 members in Canada, an 11% increase for the year, this drops to just over 5% when resignations and retirements of members are included. Vancouver gained 28 new members or 11% but resignations, and transfer out reduce our growth to slightly over 3%.

The chapter has 197 active members and our retired members (Feisters) number 66.

The board will be considering how to grow the membership and would be pleased to hear from chapter members as to what makes it worthwhile to be a member of FEI. What do you consider to be valuable and how can this be conveyed to a potential member?

### **Four New CICA Publications on Corporate Governance**

The Canadian Institute of Chartered Accountants has recently issued four new publications from the Risk Management and Governance Board.

20 Questions Directors of Not-for Profit Organizations Should Ask About Strategy and Planning by Hugh Lindsay provides guidance to members of not-for-profit boards of directors on their responsibility for strategy, planning and budgeting. It describes:

- the role of the board in developing and approving strategy, plans and budgets
- the reasons for planning and budgeting, and the processes by which strategies, plans and budgets are typically developed and approved.

**Four New CICA Publications on Corporate Governance** 

20 Questions Directors Should Ask About Crisis Management by Doug Enns and Hugh Lindsay is designed to help members of boards prepare for and handle crises. It is intended primarily for directors and boards of publicly-listed companies but, as good practice, may be of value to other organizations. The document was originally published as "Crisis Management for Directors" in 2001 – just after the attacks on the World Trade Center on September 11, 2001 and shortly before the collapses of Enron and other major corporations. This updated version reflects the lessons from these and other events which represent extreme examples of crises for organizations and the people who are affected by what happens to them.

20 Questions Directors Should Ask About Directors' and Officers' Liability Indemnification and Insurance by Richard J. Berrow explains the protection available to them under corporate indemnification and directors' and officers' insurance.

20 Questions Directors Should Ask about Special Committees by William K. Orr, and Aaron J. Atkinson. A special committee is a committee of directors established by the board to undertake certain tasks delegated by the board in a variety of different situations, from a takeover bid to an allegation of wrongdoing. This document provides some general principles to guide directors in determining whether and when to establish a special committee as well as providing a general understanding of the duties of committee members and the manner in which those duties should be discharged.




